What happened? Lori Batoit left me a voice message on Saturday April 11, 2015, on a friend's business telephone which my counsel believes amounts to extortion stating without authority of law that if I refused to talk with her she would come over to my house. Today I also learned from my investigators PSI Noel Harrison (who I hired to investigate Ms. Batoit) that when he taked with her on the phone she threatened him with criminal consecution, asserting that by calling her to investigate her personal connection to wife/child abuser John Pennington, that she would charge him with a crime

Lroi Batoit is attempting to thwart our legal right as news reporters to investigate her, amounting to a SLAPP suit and violation of my 1st Amendment rights. Her conduct violates my civil rights and she will be sued under 42 USC 1983.
