I drew a case number and gave the number to FOX along with my name and badge number. FOX told me that she would be in the area the following week and that she would have one completed by then.

After speaking with FOX, I notified Sgt. Ruchty of the complaint. Sgt. Ruchty felt it inappropriate for any of the Deputies assigned to the Gold Bar region to investigate the complaint due to the working relationship between HILL and the Gold Bar Regional Deputies. Sgt. Ruchty asked that I complete the initial report and forward it to him to be sent to the Special Investigations Unit. Sgt. Ruchty also asked that I send a medical waiver form to FOX so that detectives would be able to obtain the information on without delay.
