

4	tell me which witness that is?
5	MS. BLOCK: There's actually several
6	witnesses in the room.

1	MS. RAGONESI: So when I inquired
2	whether he was an attorney representing her, I was
3	just met with raised tone of voice, very threatening
4	behavior, which is why I wanted to go on the record.
5	And when
6	MS. REESE (via speakerphone): Did she
7	ever state why she didn't want to go on the record?
8	MS. RAGONESI: She indicated it was her
9	deposition and that she would determine when we went
10	on the record.

8	supporter. That's it.
9	MR. WEST: Won't be speaking.
10	MS. BLOCK: He will not be speaking.
11	He is actually right here affirming that he is not
12	going to be speaking. It will be my deposition.
13	MS. REESE (via speakerphone): Okay.
14	Given that, does that change anything, Ms. Ragonesi,
15	what you were just
16	MS. RAGONESI: Sorry. We're passing
17	the phone back and forth. I want to make sure two
18	items are clear. First, that Mr. West will not be
19	note-taking or contributing in any way to Ms. Block's
20	deposition, not just verbally speaking, but assisting
21	her in any way other than with lifting the documents
22	and boxes she says she needs help with, not even
23	repeating things for her. I believe that the court
24	reporter can serve that function and would be more
25	appropriate.

1	And, secondly, I'm gravely concerned about
2	Ms. Block's belief that she can have the court
3	reporter take us off the record against my request.
4	So perhaps just an instruction from the Court that
5	Ms. Block cannot interfere with the official recording
б	of what happens during the deposition.

12	Gold	Bar's mayor?	
13	Α	July 21 or 22, I can't remember, 2009, until	
14	Dece	mber 31, 11:59 p.m., 2013.	
15	Q	Okay. And you did not serve in mayoral	
16	capad	city prior to around that time, around July 20 or	
17	so? ⁻	That's 2009.	
18	Α	That's correct.

13	MS. RAGONESI: Could you reference
14	which cause of action that would be
15	MS. BLOCK: Sure. That would be the
16	King County case, 16-2-20042-7.
17	MS. RAGONESI: And which
18	MS. BLOCK: All records
19	MS. RAGONESI: records request?
20	MS. BLOCK: Records relating to me,
21	Laura Kelly. They're all in there.
22	MS. RAGONESI: Well, my objection is
23	lodged with the record, but please go ahead.
24	MS. BLOCK: Okay.

1	BY MS. BLOCK:
2	Q And as far as logging into the Sky Valley
3	Chronicle, at any time did you forward any press
4	releases to the Sky Valley Chronicle?
5	A I forwarded press releases to quite a few
6	operations, including the Sky Valley Chronicle, the
7	Everett Herald, and some of the television stations as
8	a routine part of my job.
9	Q Okay. So at least we acknowledge that you
10	did, indeed, send press releases to the Sky Valley
11	Chronicle?
12	MS. RAGONESI: Objection, asked and
13	answered.
14	A I would assume so. That's been a long time
15	ago, and I don't remember details. But it'd certainly
16	be a logical expectation.
17	Q Are you familiar with providing any public
18	records to the Sky Valley Chronicle?
19	A I don't believe we ever got a public records
20	request from the Sky Valley Chronicle, and press
21	releases are public records. And so in that
22	manner, yeah, I've sent public record press releases
23	out.
24	Q So let's talk about the public records policy
25	for the City of Gold Bar. Explain in your own words

1 what the public records policy for the City of Gold 2 Bar was when you first started compared to your last 3 day in office. 4 MS. RAGONESI: Objection to the form of 5 the question. 6 You can go ahead and answer. 7 A Well, when I started, the policy was back 8 years ago the base things that a city could respond to 9 on 42.56 were done about the -- what is it? The --10 oh, the listing of all the document records. I forgot 11 what the term was, being onerous, and who was the 12 public records officer and all of that stuff was done. 13 And, otherwise, it was simply that way. Now, 14 November 2010, based on the previous years' work and 15 the cost to the taxpayers of that, we implemented a 16 42.56.100 document, and we put -- we budgeted 12 hours 17 a month to answering records requests. And then there 18 were some tweaks later on, had to put a document on 19 the counter that said I was public records officer. 20 And let's see. What else? And then we just 21 said, basically, we adopted by reference 42.56 model 22 rules and case law, which we actually didn't have any 23 way not to incorporate. 24 Q Okay. 25 (Exhibit 1 was marked.)

1	Q	In your own words, could you explain to me
2	what	Plaintiff's Exhibit 1 is.
3	Α	It's my oath of office as mayor dated 5
4	Janu	ary 2010. Oh, for the four-year term. That's
5	what	it was.
6	Q	Correct. Okay. So this is marked
7	Janu	ary 2010, the 5th day of January.
8	Α	Okay.
9	Q	So that was for your second term.
10	Α	No, for my first term.
11	Q	Okay. In your you served as a capacity of
12	mayo	or of July 20, 2009?
13	Α	Yeah. I don't know if you consider that term
14	or no	ot.
15	Q	What would you consider it?
16	Α	Filling in to filling in the gap. I guess
17	that's	s what's called the unfulfilled term or something
18	like t	hat. I'm not sure the exact jargon.
19	Q	And so why were you filling in a term?
20	Α	Because Crystal Hill resigned.
21	Q	Okay. And she resigned on
22	Α	July 21, 2009, if memory serves me correct.
23	Q	So this would represent the official oath of
24	office	from the elected
25	Α	As being elected, yes.

1	Q Yes. Okay.	
2	MS. RAGONESI: Just for our record,	
3	Mr. Beavers, even though you may anticipate what	
4	Ms. Block is going to ask you, if you can make sure to	
5	let her finish her question that way her record is	
6	complete, that would be great.	
7	THE WITNESS: All right.	
8	Q So, Mr. Beavers, when I read this, I read a	
9	very simple line that says "I, Joe Beavers, do	
10	solemnly swear that I will support the Constitution	
11	and Laws of the United States and the Constitution and	
12	Laws of the State of Washington, and will faithfully	
13	and impartially performdischarge the duties of the	
14	office of City of Gold Bar, Mayor for a 4-year term	
15	according to the law to the best of my ability."	
16	Would that be correct?	
17	A That's what I read.	
18	Q So you mentioned that there was an ordinance	
19	in place to deal with public records; is that correct?	
20	A No. There was a resolution in place.	
21	Q Okay. And explain the difference.	
22	A Actually, there were some ordinances. Some of	
23	the early work was done, I think, as an ordinance. I	
24	can't remember. A resolution has less formality than	
25	an ordinance. An ordinance is typically used to

2	record. Mr. Beavers, if you wish to review the

5	A They are implemented in accordance with	
6	RCW 42.56, the model rules and case law.	
7	Q Okay. And so you mentioned maybe you	
8	didn't. You mentioned you were serving as the public	
9	records officer during that time period?	
10	A Yes. I took over those duties. I can't	
11	remember when.	
12	Q Okay. But it was probably when you came in	
13	office? No?	
14	A No, it was not. It was afterwards.	
15	Q Okay. And you don't exactly remember when you	
16	took over those duties, but at least according to the	
17	resolution here with your signature your signature	
18	is on the bottom right-hand corner of the second page?	
19	A Yes.	
20	Q We have the date of 16th of November 2010.	
21	A Yes.	
22	Q Okay. So on this resolution, you start	
23	assigning public records requests. Explain to me how	
24	you're assigning public records requests and how	
25	you're actually answering them.

5	Q	You tell me, Mr. Beavers, how you answer a

9	Α	The resolution doesn't actually specifically
10	talk a	about processing. It talks about implementing
11	42.56	6.100 within Gold Bar.
12	Q	Okay. And so when somebody sends you a public
13	recor	ds request, explain the process.
14	Α	I'll explain it for the time that I was mayor,
15	whic	h was it would come in. And this was done
16	prev	ious to my being mayor in one form and then after
17	l was	s no longer mayor in a different form.
18		It would be logged in with a number of PRR,
19	the y	ear, and then dash sequence number, and it would
20	be p	ut into an Excel spreadsheet for logging in and
21	then	responded to appropriately.
22	Q	Okay. And so how would it go? Would it go
23	first c	come, first served?
24	Α	Oh, no. That's not within the public
25	that's	s not within the model rules. Model rules you

1	work to get the most number of responses out, and you
2	have to do a balance between small requests and big
3	requests. And we also made sure that everyone got
4	some response every month to the best of our ability.
5	Q Okay. And so with this ordinance, would
6	you
7	A It's a resolution. Excuse me.
8	Q Excuse me. With this resolution, would you
9	have received a public records request from the Sky
10	Valley Chronicle?
11	MS. RAGONESI: Objection, calls for
12	speculation.
13	A I don't have everything memorized. I do not
14	recollect ever receiving a public records request
15	42.56.100 from the Sky Valley Chronicle.
16	Q Thank you.
17	(Exhibit 3 was marked.)
18	Q So you have in front of you, Mr. Beavers,

2	Q	Given to them as courtesy.	
3	Α	Okay.	
4	Q	As far as the Sky Valley Chronicle, did you	
5	place	them on the priority list that you had created?	
б	Α	I did not place them on the priority list like	
7	l did	not place NPR, KIRO, KOMO, or Reuters.	
8	Q	Why not?	
9	Α	Because they were newspaper or media people	
10	comi	ng in for quotes for a deadline.	
11	Q	Okay. So you unilaterally decided that	
12	some	body that you viewed as newsworthy was able to get	
13	on	get records without ever having to be put on	
14	your	priority list? Would that be a true statement?	
15		MS. RAGONESI: Objection, misstates the	
16	testin	nony.	
17		THE WITNESS: That was what, ma'am?	
18		MS. RAGONESI: I'm sorry. I lodged an

1	And these are handled as routine things if a public
2	records request is a specific thing.
3	And we always sought to define when it was
4	going to be that official versus when it was informal,
5	which is the very normal operation for most cities.
6	Q So any of the KING 5, KIRO, KOMO, any of them
7	get placed on a priority list for the City of Gold
8	Bar?
9	A One did. I think it was KING I can't
10	remember. We had one official public records request,
11	and it was a huge one. And we talked with the guy,
12	and I told him we couldn't it was so big and so
13	involved that we couldn't do it quickly, and he said
14	nevermind.
15	Q Okay. So, basically, KING 5, KIRO, they're

10	You were sending in public records requests

12	Q The reason that you I would like to clarify
13	the record here. The reason why I was asking for
14	records is because Mr. Fejfar is using four different
15	aliases, Fejfar, Fedfar, Faybar, and he's sending out
16	invoices to PUD. And he's getting paid. And I just

20	MS. BLOCK: Okay. In the sense of
21	Mr. Beavers actually being an author of the Sky Valley
22	Chronicle, I need to know if it concerns the PRA. Are
23	there any articles that he wrote that concern the
24	Public Records Act.
25	MS. RAGONESI: But that doesn't relate
	BUELL REALTIME REPORTING. LLC

1	to your causes of action.
2	MS. BLOCK: It does.
3	MS. RAGONESI: Whether or not
4	Mr. Beavers was an author of an article in the Sky
5	Valley Chronicle is not related to the claims you're
6	making in these two cases.
7	MS. BLOCK: Well, actually actually,
8	it is, Ms. Ragonesi. Because when we're talking about
9	my public records requests, we're talking about public
10	records. We're talking about all the records that
11	Penny Brenton had reviewed, and that may or may not

1	Q And as far as when you were lobbying down in
2	Olympia working with AWC on the Public Records Act,
3	did you pass around any documents that could
4	potentially be part of this lawsuit in any nature?
5	MS. RAGONESI: Objection, calls for
6	speculation.
7	MS. BLOCK: I'm asking him to state a
8	fact, Ms. Ragonesi.
9	MS. RAGONESI: Well, in my opinion,
10	Ms. Block, you're asking him to speculate, and I'm
11	entitled to lodge my objections to your question for
12	the record.

9	A I was I was helping with the overhead
10	paperwork in 2014. That's the two episodes there.
11	Someone else did the work. I may have typed up one or
12	two things, but, basically, it was the overhead work
13	that I did. And that's all I recollect doing. And
14	then in 2015, I took a more active role and started
15	doing the physical processing to help out Mayor Loen.
16	Q Okay. So in 2015 you were doing the physical
17	processing. How long did you do that for?
18	A I ran that through approximately September
19	about October more or less. I started work Mayor

23	recollections, and I started showing her the ropes and

2	Q Okay. Do you know who Penny Brenton is?
3	A Yes.
4	Q Can you explain for the record who she is?
5	A Penny Brenton is a paralegal. She was brought
6	on to handle the public records request of back in

RAGONESI: Object to the form of 18 the question, assumes facts not in evidence. 19 A As far as I know, Dorothy Croshaw wrote her 20 own bar complaint, and she was assisted in it, to some 21 degree that I do not know, by Penny. And, like I say, 22 the reason I say that is because when I proofread the 23 bar complaint there were just sentence fragment after 24 sentence fragment. And Penny would not have had 25 sentence fragments.

1	Q To the best of your knowledge, that was not		
2	turned over to me; is that correct? Is that your		
3	testimony?		
4	A It is not a City document.		
5	Q Okay. I disagree with that, and that's for a		
6	different day with Ms. Brenton.		
7	MS. BLOCK: I'm going to have just a		
8	little bit of a break, Shannon, about ten minutes, and		
9	then I'm sure we'll finish up thereafter.		
10	MS. RAGONESI: Sounds good.		
11	(A break was taken from 3:36 p.m. to		
12	3:49 p.m.)		
13	Q We're going to go back on the record.		
14	Mr. Beavers, while Linda Loen was the mayor of		
15	Gold Bar, were you working in any other capacity		
16	besides a volunteer helping along with the public		
17	records?		
18	MS. RAGONESI: Objection, asked and		
19	answered.		
20	Q With Linda Loen specifically, I'd like you to		
21	answer that.		
22	A No. Well, I give free advice a lot, but all I		
23	did was just, for my official duty, was to work with		
24	her on the transition on public records requests.		
25	Q And what kind of advice did you give Linda		

1	Loen?
2	A Oh, I probably told her to take the classes
3	and read the law and read the case law. It was just
4	general conversation.
5	Q Conversations about what?
б	A Just what I said, that she should take the
7	classes. She should understand the law and that she
8	should look at all the public records requests and
9	what we did before.
10	Q Take what classes?
11	A Oh, the there's WAPRO has classes on public
12	records, and I think AWC had a class on public
13	records. And that's part of the new elected official
14	course is they do cover public records.
15	Q While Linda Loen was the mayor of Gold Bar,
16	did she ever threaten that she was going to resign?
17	A No.
18	Q Did she ever transfer any other duties to you
19	while she was the mayor of Gold Bar?
20	A No. In fact, she didn't actually transfer
21	that duty to me. I just was there to help out.
22	Q So she didn't come up with any type of
23	resolution or some type of ordinance designating you
24	as the public records officer?
25	A Oh, absolutely not. The whole time she was

1	the public records officer with a piece of paper
2	laying on the counter. No. I was the senior intern
3	actually. I played Robert De Nero to her Anne
4	Hathaway.
5	Q So, meanwhile, while you're playing Robert
6	De Nero to Linda Loen as it relates to Gold Bar public
7	records while you're not an elected official, did she
8	have any did she go to you and say, Joe, you're
9	going to help me out with trying to figure out what's
10	going on with the public records policy discussions
11	with Linda Loen?
12	A No. She was a strong a strong woman and
13	with a with the accounting background, she's used
14	to handling detail. And she really, you know,
15	listened, but that was about it.
16	Q Did she have any discussions or with you
17	about policy considerations as far as the records?
18	A We probably had some discussion, but
19	everything she did, she did on her own decision.
20	Q On December 6, 2013, there's an e-mail that,
21	basically, says that the two of you had communications
22	as it relates to Block. Can you tell me what that
23	communication was about, what the topic of
24	conversation was?
25	MS. RAGONESI: Objection, assumes facts

1	not in evidence.
2	A No. There's no telling.
3	Q And just a couple follow-up questions about
4	communications that you've had with the county as it
5	relates to public records or policy considerations.
6	You testified that you were with Gary Haackenson
7	was part of that conversation, and Aaron Reardon was
8	part of that conversation. Who else have you had
9	communications up at the county with as it relates to
10	public records?
11	A Well, the ones we said before, the meeting
12	that Laura and I went to at the county. We just
13	talked shop about how they did their stuff and what
14	was their retention requirements and use of a server,
15	yada, yada, and just mainly had the British guy who
16	was their IT guy there.
17	Q Would that be Tom Hartley?
18	A I have no I can't remember. I remember he
19	had a British accent, and then we discussed stuff
20	about just general discussion. And then I can't
21	recollect anything off the top of my head about public
22	records discussions otherwise except for Diana Rose
23	when we talked about, hey, what about redaction
24	software. And she said, hey, we got this third-party
25	software from New Zealand. Let me show you some

1	examples.	
2	Q From New Zealand?	
3	A Yeah. That's where I remember it being from.	
4	Q What was the name of that program?	
5	A I have no clue. It was a long time ago.	
6	Q So, Mr. Beavers, now we're we've got Diana	
7	Rose who's also providing you information as far as	
8	what the city how the city is supposed to redact;	
9	is that correct?	
10	A No. She brought us a sample of software she	
11	said they were using to redact e-mails, and it was a	
12	third-party software from New Zealand. And I looked	
13	at it, and I thought it was pretty cruddy myself,	
14	No. 1.	
15	No. 2, I wasn't going to buy software from New	
16	Zealand.	
17	So we continued on doing the paper versions	
18	and stuff like that until we ended up with Adobe	
19	software to do the job.	
20	Q And with the native format including metadata,	
21	where is the metadata on any e-mails that you	
22	redacted? Where did you place those?	
23	A We we went to the properties box, copied	
24	the metadata out of the properties box, pasted it onto	
25	a Word document at the back of the e-mail. So you	

1 have the e-mail, and after the e-mail, you either have 2 a "no metadata" if the property box was blank or you 3 have the metadata that was in the property box. 4 Q With Crystal Hill's records, the records that 5 were collected --6 A Yeah. 7 Q -- how did you get the metadata from those 8 records? 9 A We went to properties and clicked on 10 properties, and the property box comes up. 11 Q So you actually searched her BlackBerry 12 device? 13 A I did not search her BlackBerry device. 14 Michael Meyers went and downloaded all of the stuff 15 off her BlackBerry device. 16 Q Do you have -- do you know if Penny Brenton 17 had actually gone into Crystal Hill's AOL account? 18 A No. Michael Meyers went into Crystal's AOL 19 account and downloaded everything. 20 Q And at no time would Penny Brenton have been 21 in Crystal Hill's AOL account with her permission? 22 MS. RAGONESI: Object to the form of 23 the question, calls for speculation. 24 A I can't answer that, but there's nothing for 25 the City, no. It was already done by the time Penny

1	got there. All that work had been done, had been
2	completed by August. And Penny showed up in
3	September, I believe. I'm having to work off what
4	was that? 2009? '16, seven years, my goodness.
5	Q And so one of the public records requests that
6	is part of this suit called for the records from
7	Dorothy Croshaw, and your statement here today is that
8	all those records were actually obtained by
9	August 2009.
10	A All of the records that we were collecting,
11	yeah, I think from personal e-mail accounts and
12	things were I believe it was by August 2009.
13	Because what happened it had been done before and was
14	completed before then, and then what happened went
15	to a GoDaddy system.
16	And so he pulled the GoDaddy stuff off. And
17	then what happened and then he ended doing the
18	search May, June something like June 15 or
19	something, and everybody was using GoDaddy except for
20	Crystal. And so he had to go back into Crystal's
21	July late July and get the retaining parts, get the
22	parts that occurred between when he finished and then.
23	Q And did Michael Meyers go into Dorothy
24	Croshaw's Comcast account, dcroshaw@comcast.net?
25	A I don't know the details of that. I know he

L

1	worked on it, and then I went and inspected her		
2	computer to see if there was anything on it.		
3	Q So you're not absolutely positive that Dorothy		
4	Croshaw's e-mail account was ever searched?		
5	A I'm not I'm not sufficiently up to date		
б	technically on she was using Outlook Express, and I'm		
7	not an ace expert on that at all.		
8	Q Did Michael Meyers ever mention to you that		
9	he that Dorothy Croshaw would not give him		
10	permission to go into her Comcast account?		
11	A I don't recollect. I know Dorothy was		
12	probably the technical low end of everybody we worked		
13	with.		
14	Q I didn't ask that. I just asked if you were		
15	aware that Michael Meyers		
16	A I can't really		
17	Q was not given permission by Dorothy Croshaw		
18	to search her personal e-mail accounts?		
19	A I		
20	MS. RAGONESI: Object to the form of		
21	the question, assumes facts not in evidence.		
22	A I can't remember the exact details. I did go		
23	and look at Dorothy's Outlook Express to see if there		
24	were any City e-mails on it, and she had forwarded,		
25	evidently, all relevant e-mails to Laura. But that's

1	about that's a long memory. I have to go back
2	and I probably could not reconstruct it.
3	Q Okay. So Dorothy Croshaw, to the best of your
4	knowledge, did she use the City e-mail address, such
5	as cityofgoldbar.usa, Dorothy Croshaw?
б	A I'm certain she did, but, again, that was a
7	long time ago. I'd have to go back and look at the
8	e-mails to see who used what.
9	Q Besides dorothycroshaw@comcast.net and the
10	City of Gold Bar e-mail address, did Dorothy Croshaw
11	use any other e-mail address that you know of?
12	MS. RAGONESI: Objection, assumes facts
13	not in evidence with regard to her personal e-mail.
14	A I don't know.
15	MS. BLOCK: It's in the suit.
16	MS. RAGONESI: That doesn't mean it's a
17	fact in evidence.
18	MS. BLOCK: It's okay.
19	Q So, Mr. Beavers, Chuck Lie was a Gold Bar city
20	council member. We talked about him a little bit
21	earlier. Did you ever threaten him with legal
22	prosecution if he didn't shut his fucking mouth, end
23	quote?
24	A No, not legal prosecution.
25	Q Did you ever did you ever was there ever

1	a conversation in Gold Bar City Hall where you jumped		
2	in Chuck Li's face in front of Deputy Martin and say,		
3	"You better keep your fucking mouth shut, or I'll have		
4	you fucking arrested and prosecuted"?		
5	A No, I never said that. I think I called him a		
б	stupid motherfucker, but I didn't do that.		
7	Q Did you ever say the Public Records Act, in		
8	quote, was a big fuck you?		
9	A I that sounds like something I might have		
10	said.		
11	Q Are you aware that Deputy Martin was present		
12	during that conversation?		
13	A Yes.		
14	MS. RAGONESI: Objection, assumes facts		
15	not in evidence.		
16	Q September 23, 2013, there was a hearing at		
17	Snohomish County as it relates to public records, and		
18	I had my counsel present, Bill Crittenden. Did you		
19	spit in Bill Crittenden's face that day?		
20	A No.		
21	Q Are you aware that the halls of Snohomish		
22	County are actually videotaped?

19	yelling at the judge and doing stuff. It was really

23	rest of the attorneys were sort of looking around, and
24	so then he came out in the hallway as we were leaving
25	and started making noise about how I was, you know,

7	of the	em? That there were 66 records that you did not	
8	lodge	for the in camera review that are now going to	
9	be su	bject to a CR-60 motion next month?	
10	Α	I have no clue.	
11		MS. RAGONESI: Object to the form of	
12	the q	uestion, misstates	
13	Q	Are any of these	
14		THE REPORTER: One at a time, please.	
15	Q	Are any of these records, records that I am	
16	seeking in this lawsuit?		
17		MS. RAGONESI: Objection, calls for	
18	speci	ulation.	
19	Α	l have no idea what you're talking about.	
20	Q	So explain to me. You stated that it was a	
21	guy tl	ning between you and Bill Crittenden. What does	
22	that r	nean?	
23	Α	Well, sometimes guys when they try to make an	
24	intim	idating statement to you, you have to show that	
25	mayt	be you're not intimidated.	

1	Q And you feel that Mr. Crittenden made an	
2	intimidating statement to you?	
3	A Oh, absolutely, yes, yes.	
4	Q How did he do that?	
5	A He was in there claiming that I don't	
6	remember the exact word but how the attorneys were	
7	taking everybody to the cleaners, and here I was I was

1 money is actually coming from. 2 MS. RAGONESI: And, again, I would just 3 respond that this lawsuit isn't about all public 4 records. 7	stealing from the City of Gold Bar?

9	MS. RAGONESI: Object to the form of

11	deposition, argumentative, and harassing and no facts

13	Q We talked about Jay Prueher earlier.
